### ONLINE REGISTRATION **(COMPLETE ALL TABS IN FULL)**

1. Complete all fields on all tabs of the Online Registration
2. Upload the following forms (as applicable) by
  - a) Downloading the form from the provided link
  - b) Completing the fillable form
  - c) Save fillable form as: Student's Name.Form Name (i.e., *John Jones.Home Language Survey*)
  - d) Uploading using the Upload Button:
    - Health Conditions Form **(Required when you list a Health Condition)**
    - Current Immunization Record (See required list below)
    - Home Language Survey
    - Court Records/Custody Papers (As Applicable)
    - Title VI Eligibility Form and copy of CDIB Card (As Applicable).
    - Proof of Residency Documents (see list below)
3. Submit Application **AFTER** uploading all forms and completing all fields. PLEASE NOTE:  
**Once you submit, you cannot re-enter the application to revise or add.**

### IMMUNIZATION REQUIREMENTS FOR 2018-2019 PRE-KINDERGARTEN STUDENTS:

### RESIDENCY:

Pursuant to State Law, **we are required to Verify Residency of students attending our District upon Enrollment/Registration submission** and again in July/August prior to the first day of school.

Guardians are **required** to present:

- Settlement Statement, Warranty Deed, Mortgage Statement OR Current Lease
- Two CURRENT (January, February or March bill) Utility Bills (gas, water or electric) in guardian's name at the guardian address
- New Student Residency Affidavit
